The team is composed of young and highly energetic ladies and gentlemen from the greater East African region with members having experience of between 5-9 years in their respective docket roles.



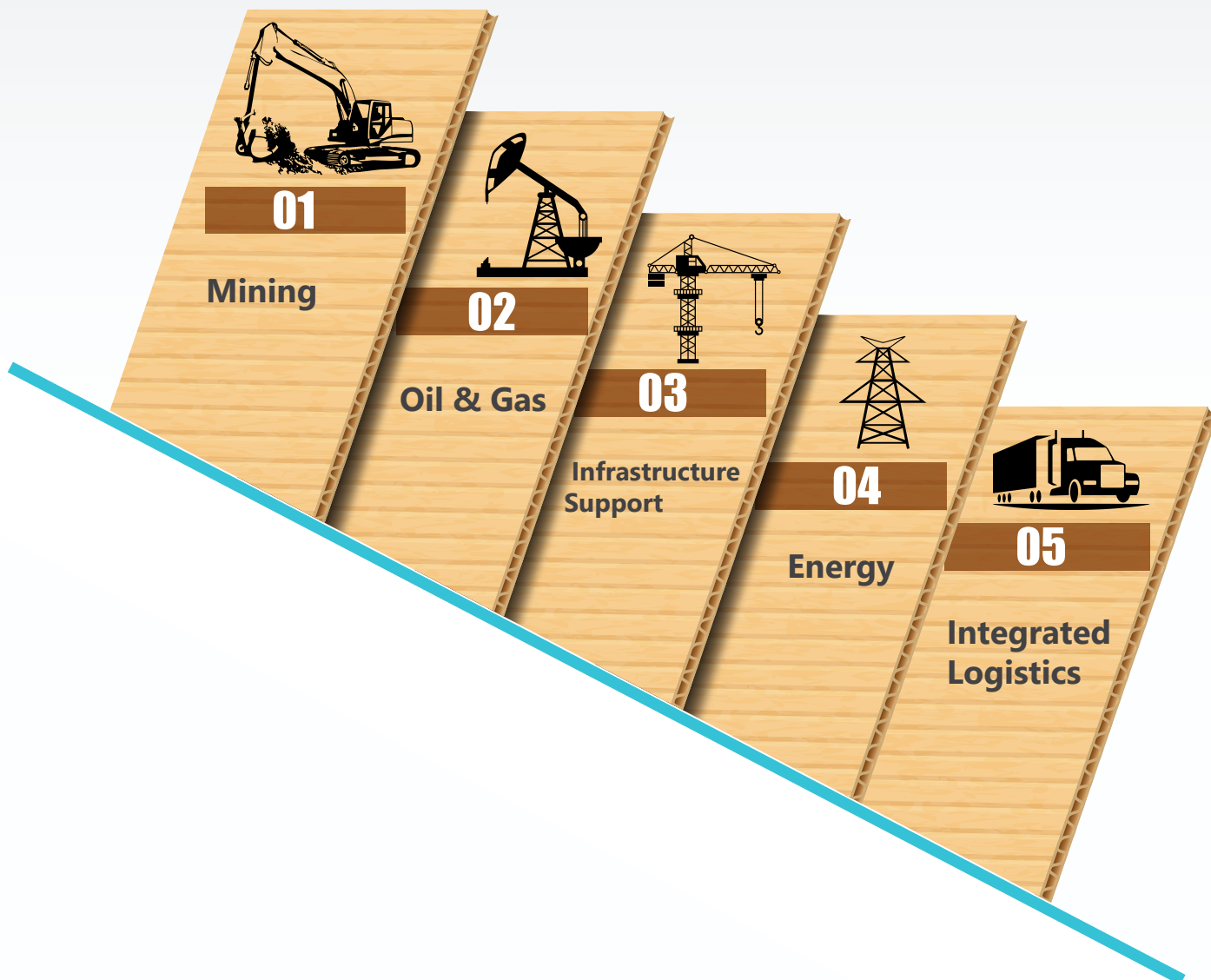
